# **APPLICATION FOR LICENCE FORM**

## **NOTICE TO APPLICANTS**

Part 4 of the Rules of Harness Racing Victoria relates to licensing of participants by Harness Racing Victoria.

HRV may by licence regulate any activity connected with the harness racing industry (Rule 90(1)) and may require such documentation, information or fees as it determines to accompany any application for a licence.

HRV may grant a licence for such period and upon such terms and conditions as it thinks fit, and may refuse a licence without assigning any reason whatsoever (Rules 90(4) & (5). Ultimately, the grant or otherwise of a licence is at the discretion of the Board of HRV.

The licensing criteria provided below has been set by the Board of HRV to assist persons wishing to apply to be licensed by HRV in the relevant licence categories.

Without limiting the powers of HRV provided in the Rules and in the Racing Act 1958, the Board of HRV may in its discretion:

- vary or amend the licensing criteria at any time;
- · require additional information to accompany a licence application;
- impose terms and conditions on the grant of a licence;
- take into account any other matter it considers relevant in determining a licence application.

## Harness Racing Victoria Privacy Statement

In relation to your application for licence renewal, HRV collects personal information from you in order to assess the application and if approved, to manage and supervise your ongoing status as a licensed person and as a in the Victorian harness racing industry. To do this, we may disclose your personal information to other persons or organisations, including enforcement bodies, State Government licensing authorities and other racing control bodies. Your name, address, telephone number and email address is also placed on HarnessWeb for access by subscribers to this service and HRV employees who use HarnessWeb in carrying out their employment. You do not have to supply the information requested in the application, but if the information (or any part of it) is not provided, your application may be rejected. By completing and submitting the application, and any supporting documentation, you authorise HRV to collect, use and disclose information about you for the purpose described above and in the Privacy Policy plus for the purpose of promoting harness racing.

Grade B Driver (Please Tick)
The holder of a Grade B Driver licence may drive in trials, shows and gymkhanas, and is licensed to drive at graduation meetings and, other than races of a metropolitan class, at country or provincial meetings, including country or provincial class meetings at metropolitan sites.
Attained the age of sixteen (16) years.
Been interviewed to the satisfaction of the Stewards
Completed thirty (30) trial drives to the satisfaction of the Stewards and held a Grade C Driver's licence not less than six (6) months.
Grade A Driver (Please Tick)
The holder of a Grade A Driver licence has the driving rights of both C & B Drivers and is licensed to drive at any meeting.
Attained the age of sixteen (16) years.
Completed one hundred and twenty (120) drives to the satisfaction of the Stewards and held a B Driver's licence not less than twelve (12) months.
Grade C Trainer (Please Tick)
The holder of a C Grade Trainers Licence is licensed to prepare, educate and exercise a horse but cannot nominate such horse to trial or race.
Provided a minimum of two (2) work references attesting to the applicants horse handling ability. References from licensed trainers must include – the period they have knowledge of the applicant's experience handling Standardbred horses and the duties undertaken
Provided a certificate of completion of an assessment at the Harness Racing Training Centre or other accredited training centre
Provided proof of enrolment to commence mandatory training modules and satisfactorily completed a practical training assessment.
Provided a minimum of two (2) credit references (Vet, Farrier, Feed Suppliers etc) stating that the applicant's accounts are paid promptly
Provided a credit report by contacting a credit reporting body.
Bank account statements in the applicant's name for the preceding three (3) month period (to the date that the application is submitted to HRV) and an Accountant/Bank Officer to form part of the Accountant Reference declaration accompanying the application form.
Proof that the applicant leases owns or has access to stables suitable for the training of Standardbred horses.
Grade B Trainer (Please Tick)
The holder of a Grade B Trainer licence may train any registered horse which the person owns or partly owns or which is owned by the person's spouse, other domestic partner, parent, sibling or child. The holder may also train up to a maximum of three (3) horses for outside clients (ie. not family related) at any one time by seeking written approval from the Stewards.
Attained the age of eighteen (18) years.
Provided a minimum of two (2) work references attesting to your horse handling ability. References from licensed trainers must include – Period of time they have known you working with Standardbreds and duties undertaken
Minimum of two (2) credit references (vet, farrier, feed supplies etc) stating that your accounts are paid promptly or a credit report.
Provided a credit report by contacting a credit reporting body.
Provided a certificate of completion of an assessment at the Harness Racing Training Centre or other accredited training centre.
Provided proof of enrolment to commence mandatory training modules and satisfactorily completed a practical training assessment
Bank account statements in the applicant's name for the preceding three (3) month period (to the date that the application is submitted to HRV) and an Accountant/Bank Officer to form part of the Accountant Reference declaration accompanying the

# Grade A Trainer (Please Tick)

The holder of a Grade A Trainer licence may train any registered horse.

- Attained the age of fourteen (18) years old
- Two (2) references from licensed trainers
- Provide a minimum of two (2) credit references (Vet, Farrier, Feed Suppliers etc) stating that your accounts are paid promptly.
- Bank account statements in your name for the preceding three (3) month period (to the date of your application is submitted to Harness Racing Victoria & Accountant/Bank officer)
  - Held a Grade B Trainer for twelve (12) months or or has been employed as a stable foreman by a Grade A Trainer for a minimum of twelve (12) months and produces a reference from such trainers.
