PRIVACY STATEMENT - COLLECTION OF PERSONAL INFORMATION

Harness Racing Victoria (HRV) collects personal information from you in this form in order to manage and supervise your participation in the harness racing industry.

To do this, we may disclose the personal information, including financial information, to other persons or organisations, including enforcement bodies, State or Federal Government licensing or compliance authorities and other racing control bodies.

You do not have to supply the information requested in this form, but if the information (or any part of it) is not provided, your application may be rejected. By completing and submitting the application, and any supporting documentation, you authorise HRV to collect, use and disclose information about you for the purposes described above. In most cases, you can gain access to your personal information and request that corrections be made to it, if necessary.

Only use this form if you are a Genuine Hobbyist who is not able to claim a credit for GST paid on your harness racing purchase. If you wish to be able to claim back GST that you pay on your purchases you should register for GST with an Australian Business Number (ABN) - and not complete this form.

This declaration is only available to individuals, syndicates, groups or partnerships under Section 12-190 (6) of the New Tax System (Pay As You Go) Act 1999 – not companies, trusts or other entities.

1. I/We understand that under the New Tax System if I/we am/are a hobbyist participant in harness racing I/we will be unable to claim an input tax credit (“refund”) for Goods & Services Tax that I/we pay on my/our purchases.

3. I/We declare that my/our supply of horses for harness racing is undertaken without reasonable expectation of a profit. I am not carrying out an enterprise as set out in the GST legislation. Should any of these circumstances change I/we will advise Harness Racing Victoria immediately.
